Executive Director stated that ORDA requested \$200,000 from the Promotion Fund. The recommendation was \$180,000.

<u>A motion was made</u> by Commissioner Schmitz and seconded by Commissioner Benson to go with the Director's recommendation of \$180,000 from the Promotion Fund for ORDA. Schmitz – Y, Benson – Y, and Hanson – Y. Motion passed.

Executive Director stated that ORDA requested \$25,000 from the Promotion Fund for a horsemen's incentive, and he recommended approval.

<u>A motion was made</u> by Commissioner Benson and seconded by Chairman Hanson to go with the Director's recommendation of \$25,000 from the Promotion Fund to ORDA for a horsemen's incentive. Benson – Y, Hanson – Y, and Schmitz – N. Motion passed.

Executive Director stated that ORDA requested \$200,000 from the Purse Fund. The recommendation was \$140,000.

<u>A motion was made</u> by Commissioner Schmitz and seconded by Commissioner Benson to go with the Director's recommendation of \$140,000 from the Purse Fund to ORDA. Schmitz – Y, Benson – Y, and Hanson – Y. Motion passed.

c. HRND (North Dakota Horse Park)

Executive Director stated that HRND requested \$180,000 from the Promotion Fund. The recommendation was \$180,000.

<u>A motion was made</u> by Commissioner Schmitz and seconded by Commissioner Benson to go with the Director's recommendation of \$180,000 from the Promotion Fund to HRND. Schmitz – Y, Benson – Y, and Hanson – Y. Motion passed.

Executive Director stated that HRND requested \$7,500 from the Promotion Fund for additional RV hookups. The recommendation was \$7,500.

<u>A motion was made</u> by Commissioner Benson and seconded by Commissioner Schmitz to go with the Director's recommendation of \$7,500 from the Promotion Fund to HRND for additional RV hookups. Benson – Y, Schnitz – Y, and Hanson – Y. Motion passed.

Commissioner LaFromboise joined the meeting on the phone.

Executive Director stated that HRND requested \$196,000 from the Purse Fund. The recommendation was \$140,000.

<u>A motion was made</u> by Commissioner Schmitz and seconded by Commissioner Benson to go with the Director's recommendation of \$140,000 from the Purse Fund for HRND. Schmitz – Y, Benson – Y, Hanson – Y, and LaFromboise - Y. Motion passed.

d. North Dakota Thoroughbred Association

Executive Director stated that the NDTA requested \$3,000 from the Promotion Fund and he recommended approval.

<u>A motion was made</u> by Commissioner Benson and seconded by Chairman Hanson to approve a Promotion Fund request to NDTA in the amount of \$3,000 for a horsemen's banquet to be held in Fargo on the last weekend of racing. Benson – Y, Hanson – Y, Schmitz – Y, and LaFromboise – Y. Motion passed.

Scott Horst, President of the NDTA, withdrew their Purse Fund Grant request.

e. North Dakota Quarter Horse Racing Association

Executive Director stated that the NDQHRA requested \$5,000 from the Promotion Fund and he recommended approval.

<u>A motion was made</u> by Commissioner Benson and seconded by Commissioner Schmitz to approve a \$5,000 Promotion Fund request to NDQHRA for their awards banquet with the NDQHA. Benson – Y, Schmitz – Y, Hanson – Y, and LaFromboise – Y. Motion passed.

Leon Glasser, President of the NDQHRA, withdrew their Purse Fund Grant request.

Executive Director Johnson stated that he recommended a jockey incentive of \$12,000 from the Promotion Fund for each racetrack.

<u>A motion was made</u> by Commissioner LaFromboise and seconded by Commissioner Schmitz to approve a jockey incentive of \$12,000 from the Promotion Fund for Chippewa Downs (ORDA) and the North Dakota Horse Park (HRND). LaFromboise – Y, Schmitz – Y, Hanson – Y, and Benson – Y. Motion passed.
