1. Approval of Minutes – March 5 & March 26, 2020

<u>A motion was made</u> by Commissioner Hanson and seconded by Commissioner Bata to accept the minutes of March 5 & March 26, 2020, as presented. Commissioner Kreidt and Commissioner Martin were not present. All Commissioners voted aye and hearing no negative vote the motion passed.

2. Horse Race North Dakota Audit

Director Schulz updated the Commissioners as to the status of the audit of Horse Race North Dakota.

3. 2020 Race Meets

a. ORDA (Chippewa Downs)

Director Schulz provided an update on the status of racing at Chippewa Downs for this year. Doug DeMontigny also gave an update on the dates requested for this year's race meet. Director Schulz recommended starting a week later beginning June 13 or else running the races during August.

<u>A motion was made</u> by Commissioner Bata and seconded by Commissioner Hanson to revise the race dates for Chippewa Downs from June 13 through July 12 or during August 1 – 30. Horse Race North Dakota is not running on July 11-12. Bata – Y, Hanson – Y, Piepkorn – Y, and Kreidt – Y. Motion passed.

b. HRND (North Dakota Horse Park)

Director Schulz advised that there are no changes necessary for the meet at the North Dakota Horse Park. They are planning on running on July 17 & 18 and July 25 & 26.

c. Televised and ADW Wagering During the Live Race Meets in North Dakota

Director Schulz stated that there are talks to possibly having the race meets be televised.
