- Leigh Backhaus stated that the State Veterinarian and the Veterinarian giving Lasix should not be using the same vein on a horse.
- Hugh Drexler stated that he thought it would be beneficial to have a meeting between the Commission and the two track operators to explore the possibility of buying some machines.
 - Mr. Drexler also talked about improving communication between the tracks and how to make it better. TextCaster is what they used this year, and they plan on using it again next year.
- Scott Horst asked about Fair Circuit Board and whether they are still active.
- Chairman Hanson had some ideas for next season:

 - Start talking about the next Legislative session
- Leigh Backhaus if the rule can be changed regarding having an ambulance during training hours.
