# **MADDIES BLUES**

There are days at sporting events when one competitor draws the cheers of the avid fans. One of those magic moments took place at Chippewa Downs in Belcourt on June 16 during the ninth race.

The stage was set at 6½ furlongs in a \$2,500 thoroughbred claiming race. A longtime favorite, Maddies Blues, walked onto the track and carried the demeanor of a racing veteran. Maddies Blues, a 12 year old bay gelding owned by Curt Rohweder of Wishek, has been an old hand at the racing game. Maddies Blues has galloped around the oval on 53 occasions, crossing the finish line first 14 times, second 9 times and third 5 times, collecting over

# WHO ARE THESE GUYS? MEET MARK THURMAN

The Racing Commission has expanded its support services to monitor and audit the wagering that is being conducted by the Simulcast and Account Deposit Wagering companies licensed in North Dakota. Wagering is a unique and complicated process that requires expertise and everyday practical application to gain the skills necessary for the proper accounting of the funds.

As we reported in our last newsletter, the Racing Commission recognizes the complexity of this process and worked with OMB's Procurement Office to secure the best possible experts to audit the wagering. The bid was awarded to CHRIMS, formerly known as the California Horse Racing Information Management Systems from Dublin, California. CHRIMS is under the guidance of their able President, Mark Thurman, who has been

Three of the licensed North Dakota Account Deposit Wagering Companies have stepped forward in a large way to ensure of the reopening of the track. BetAmerica pledged \$18,000 for the track operations. BMI, a local ADW firm, stepped forward with a \$36,000 dollar gift to open the gates of the race track again. Avatar, North Dakota's largest ADW company, is providing the financial support for funding the Track Manager, Public Relations Manager, and the consulting expertise of Bruce Soulsby.

The North Dakota Racing Commission has granted \$18,000 for the operations of the meet and \$89,000 from the Purse fund for prize money for the horsemen.

Come out and enjoy two weekends of racing in Fargo on July 14<sup>th</sup> & 15<sup>th</sup> and the 23<sup>rd</sup> and 24<sup>th</sup>!

\$120,000 at the pay window. Maddies Blues did it again at Belcourt on the last race competing with 7 other experienced thoroughbreds. He was in the middle of the pack on the first turn and then headed into the back stretch with his long easy stride. As the opponents dug down to summon the speed to take over first, Maddies Blues just kept that steady sure pace and never seemed to hurry as he passed one challenger after another.

When the eight horse field reached the home stretch Maddies Blues was in the lead with his easy stride and the seven rivals came on with a rush. The senior citizen of racing again lengthened his stride and broke across the finish line first to the cheers of the crowd.

Maddies Blues was there racing due to the care of his owner, and through the cooperation of the Racing Commission and the Legislative Branch. On July 1, 2011 Administrative Rule changes were implemented to allow horses to earn Breed Fund points up to age twelve. The Administrative Rules Committee heard the presentation by the Racing Commission and allowed this rule change to become administrative law which will lengthen the earning potential of these gifted athletes. All of North Dakota crossed the finish line in first place with Maddies Blues at Chippewa Downs.

with CHRIMS since its inception in 1989. Mr. Thurman has been at the helm as horse racing progressed from on-track only wagering through off-track betting sites, to simulcast, and now through account deposit wagering. His leadership has provided accounting services for many of the large U.S. tracks, auditing for state governments, and connectivity from all data sources to one central location for examination and reporting.

Mr. Thurman is a Certified Public Accountant who was a partner in the firm of Thurman and Thurman, who served the racing industry, which provided his entry into the horse racing world. Mark has worked with the majority of the large tracks across the nation, including Churchill Downs, New York Racing Association, Breeders Cup, Gulfstream Park, Santa Anita, Hollywood Park, Del Mar and almost every major racing facility in the U.S. This experience and understanding of the horse racing world has been an invaluable asset to North Dakota. The Racing Commission is fortunate to have this nationally known firm as a partner in the monitoring and accounting of the wagering conducted through North Dakota licensed companies.

CHRIMS and other strong racing and wagering connections are building a creditable regulating team within the borders of North Dakota. We welcome Mark Thurman and his team to North Dakota and look forward to building a solid future with these nationally respected partners.


# CHAIRMAN JIM OZBUN A True Gentleman and Scholar

He graduated from Flasher High School in 1955 where he had been president of both his junior and senior classes and had lettered in football, basketball and baseball. Jim obtained his B.S. and M.S. degrees from North Dakota State University and his Ph.D. in Soils and Plant Physiology from North Carolina State University in Raleigh, N.C. He served on the faculty and in various leadership positions at Cornell University, the University of Minnesota, Kansas State University, Washington State University and as President of North Dakota State University.

His research and teaching was primarily related to physiology and nutrition of crop plants. He has more than 50 scientific journal publications and extensive international experience and consulting, including time in China, Morocco, Jordan, the Sudan, and Columbia.

He retired as President Emeritus from NDSU in 1995 and purchased a small cattle ranch in western North Dakota where he raised registered Hereford cattle and registered Quarter horses. In 2000, Jim was bucked off his horse while working cattle and ruptured his bladder and broke his pelvis. The good news is that he has recovered fully and can still ride.

In 2010, he and his wife, Sonja, sold the ranch and moved into a retirement community on the Dickinson State University campus. They continue to be active in the Dickinson community and are involved in many community projects. They have been married for 53 years and have two married children, six grandchildren, and one great-grandson.

Among his accomplishments as Chairman, Jim believes most significant is that the Racing Commission has built a positive relationship with the various racing entities and has established a business-like atmosphere for conducting commission activities. For the future, he would like to see the Racing Commission obtain the necessary financial resources so as to allow 4 to 5 weeks of racing in both Fargo and Belcourt each season. This would be of benefit to the North Dakota horsemen, the communities of Fargo and Belcourt, and to the economy of the state.
